# **STUDENT ACCOUNT POLICIES**

## **Please read before enrolling student(s).**

1. Tuition is due the 20th of each month and will be applied to the following month's tuition. A \$10 late fee will be charged to all accounts that are paid after the 1st day of the month. Athletes whose accounts are 30 days or more past due may lose their spots in classes.
2. If you attend one or more classes in a given month, you are liable for that month's tuition. We do not prorate tuition except for the initial month.
3. We require a minimum of two weeks written notice for class and/or team withdrawal. You will be charged for the two weeks, and your children are encouraged to attend classes.
4. An annual enrollment fee of \$35 per student (maximum of \$70 per family) is due on each anniversary date of enrollment.
5. A \$30 charge will be made for each returned check and/or ACH.
6. If an account is submitted for collection, a \$25 processing fee will be added.
7. Our tuition is based on a yearly tuition rate divided by 12 to arrive at our monthly tuition. Holidays and breaks are factored into the setting of tuition; therefore, we do not prorate for these closings. We do offer make-ups for bad weather and other unplanned closings.
8. Make-ups must be arranged by contacting the main office staff or going online to select a make-up class. Make-ups are not guaranteed and are available only if there are class openings. To qualify for make-ups, students must be actively enrolled in classes. One make-up per month is permitted. Call 972-731-5888 or go to [www.expresscheer.com](http://www.expresscheer.com) to arrange make-ups.
9. Private lessons are available for currently enrolled students. Please contact the coach directly to arrange a private lesson. Payments are to be made to the coach prior to the beginning of the lesson.
10. Be sure to contact the office staff, not the instructors in writing, in person, by phone, or via the internet to change classes, phone numbers, to make a payment, and/or withdraw.
